Scholarship Information

Security First Credit Union will be awarding five \$2,000 scholarships. A Scholarship Committee made up of SFCU employees and/or Board Members will be responsible for reviewing scholarship applications. Scholarships are awarded based on a student's academic achievement, participation in school and community activities, personal statement and references.

The scholarship application will become available on March 13, 2017.

The completed scholarship application is **due by April 14, 2017**, to <u>sabina.martinez@securityfirstcu.com</u>. Applicants will be notified via email once scholarship packet is complete. Scholarship recipients will be contacted on or before May 15, 2017 and be announced on our website and social media pages.

All scholarship funds will be made payable directly to the institution of higher education toward tuition and fees. College or university address and contact information must be provided before funds are disbursed.

Criteria

The student must:

- Be the primary owner of an active account (Share Savings, Checking, etc.) in good standing at Security First Credit Union as of 1/1/2017. Custodial accounts **DO** qualify.
- Applicant must be classified as a 2017 High School Senior in the Rio Grande Valley (Hidalgo, Willacy, Starr, Cameron), or currently enrolled in a college or university.
- Be accepted to an accredited college or technical school at the time of award.

Terms of Ineligibility

- The use of a parent, guardian, relative, or friend's account membership is not permitted and does not qualify applicant for account status.
- The account of the applicant not be in good standing.
- Previous scholarship recipients are ineligible for reapplication.
- Reference forms completed by family members or friends.
- Employees of Security First Credit Union are ineligible for scholarship application.
- Incomplete applications will not receive scholarship consideration.
